**RE : URGENT NOTICE FROM THE PRESIDENT**

1. The President of the Republic of South Africa, President Cyril Ramaphosa has addressed the nation on the 15<sup>th</sup> and 23<sup>rd</sup> of March 2020 respectively. In his two addresses he announced measures that the country should comply with in the response to the Covid -19 virus.
2. A Nationwide lock down will commence at midnight on the 26 March 2020 and will be in effect until 16 April 2020.
3. As the Sheriff's Offices we render our services in line with the decision that are taken in Court and comply with all relevant rules and directives thereof.
4. Based on the above the Sheriff Centurion East will be available on a standby basis and will execute any processes that falls within our Jurisdiction in line with the applicable legislation. We will be ready and available when required by the Courts and clients to execute any processes as directed by the Minister of Justice and Correctional Services and other relevant Directives issued.
5. We are aware that there are pending sales in executions for both movable and immovable property that our office was preparing to execute as ordered by the courts with instructions from various attorneys, unfortunately this will also be suspended during this period of the nationwide lockdown
6. In relation to the Road Accident Fund matters we will continue to prioritize the Execution of Warrants as well as payments once same has been received .
7. We are aware of the legal implications and the inconvenience that this might cause to our clients but as responsible South Africans , we are compelled to comply with the President of the Country's pronouncements
8. I hope that the above arrangements will enable all of us within the Security Cluster to continue rendering services to our clients whilst fully complying with the directives issued by the President
